

LIMITED WARRANTY

We, *Best Rolling Doors*, ("manufacturer"), hereby warrants the products sold under this warranty to be free from defects in material and workmanship under normal use and service for a period of **two (2) full calendar year** from date of delivery to the original purchaser ("buyer"). All claims under this warranty shall require proof of purchase.

Manufacturer will, under this warranty, repair or replace (material only), at its election, any part which shall be determined by manufacturer to be defective, conditioned upon buyer giving written notice of any such defect to manufacturer within the warranty period. This warranty does not include labor charges for dismantle, repair or re-assembly. There are no warranties which extend beyond those stated herein.

This limited warranty excludes:

- 1- Rust caused by damages or scratching.
- 2- Damages caused by accident, improper use, negligent operation, improper installation, improper maintenance or normal wear.
- 3- Damages caused by shipping, installation or labor charges.
- 4- Defects in paints or coatings used to finish door sections.
- 5- Any product or component which is modified, altered, or not part of the original door.
- 6- Damage resulting from exposure to corrosive chemicals, corrosive fumes, condensation, water or fire.
- 7- Dents, scratches, paint wear, component wear or any damage incurred from handling, installation or normal operation is beyond control of the factory and specifically excluded herein.
- 8- Damages resulting from any circumstances beyond the direct control of *Best Rolling Doors*.

In the event of a defective component, contact the dealer where the door was purchased. *Best Rolling Doors* reserves the right to inspect all products alleged to be defective and to verify eligibility of this limited warranty. In no event shall the liability of *Best Rolling Doors* exceed the invoice value as stated in the above referenced contract.

This warranty shall be null and void, and all claims arising hereunder, or by operation of law, shall be waived if the products designated in the above referenced contract are not installed and maintained pursuant to installation specifications and/or instructions as published by *Best Rolling Doors*.

Best Rolling Doors reserves the right to change, discontinue, or alter any of its products, or the parts incorporated into any of its products, at its sole discretion. If an identical model, part or component is not available at the time of any claim under this warranty, *Best Rolling Doors* reserves the right to substitute any other model, part or component as a replacement.

THIS LIMITED WARRANTY EXCLUDES ANY LOSS OR DAMAGE NOT SPECIFICALLY UNDERTAKEN HEREIN, INCLUDING, WITHOUT LIMITATION, ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES, SUCH AS DEATH, INJURY, DAMAGES TO PROPERTY, OR DAMAGES ARISING FROM LOSS OF USE OF ANY PRODUCT OR FACILITY. ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND OF MERCHANTABILITY, ARE HEREBY EXPRESSLY EXCLUDED.

This warranty extends only to the direct purchaser (distributor, wholesaler or contractor) from *Best Rolling Doors* and is not transferable.
